Contributions may be made by payroll deduction, cash, check, credit card, or gifts of stocks; must be designated to Lycoming, Sullivan or Tioga County Community Fund or a Program Partner. 2. Provided information for winning entries must be verified to prior release of rewards. 3. United Way staff member, their immediate families, as well as LCUW board members and their immediate families, are not eligible. Immediate families include spouses, parents, children, and their respective spouses. 4. Names will be chosen at the conclusion to the campaign. It is not necessary to be present to win. Winners will be notified by phone. If winner cannot be located, an alternate name will be drawn for that reward. 5. By entry into this program, winners agree to permit use of their names and photographs for publicity purposes. 6. The winners will be required to sign a release and hold harmless agreement in favor of our Official Campaign Sponsors, as well as LCUW and their respective agents and employees. 7. How It Works
